

MINUTES OF THE MEETING OF PADIHAM TOWN COUNCIL

2. **APOLOGIES FOR ABSENCE:** Town Councillors P. Hall and C. Smith
3. **PUBLIC QUESTION TIME** – the Town Clerk reported that there had been no requests to speak
4. **DECLARATIONS OF INTEREST** – Town Councillor D. Rushton in relation to the Planning matter otherwise none apparent but to be made during the course of the Meeting as necessary
5. **MINUTES OF THE MEETING** held on 4th January 2010 were PROPOSED by Cllr. J.W. Billinger and SECONDED by Cllr. A.M. Jkinson AGREED UNANIMOUSLY
6. **MATTERS ARISING AND UPDATED INFORMATION**
 - a) **Linear Park – Off Road Vehicle Signage** – the Town Clerk provided a revised template of the intended signage and this was AGREED UNANIMOUSLY. The signs will be of metal construction 300mm x 400mm.
 - b) **Linear Park – Dog Fouling** - Cllr. Kenyon again identified this problem. Sgt Cussans assured Councillors that a joint operation was to be carried out to apprehend offenders in Padiham. At the present time there is no provision for enforcement on the Linear Park. It was AGREED UNANIMOUSLY that the Town Clerk write to Burnley Borough Council and Lancashire County to expedite the statutory procedures. Town Councillors attending the Padiham Greenways Meeting on 2nd February will emphasis the necessity for appropriate action.
